**RAIN SITE:** will be announced through local media or Facebook (Nelson Fair).

**RULES:**

1. All contestants will pay gate admission.
2. All contestants must be a resident of Nelson County as of June 30, 2017. Proof of residency could be required if necessary.
3. Girls and boys will be judged separately in the following age groups:
  - A. 25-36 months
  - B. 37-48 months
  - C. 49-59 months
  - D. Multiple births, 25-59 months (twins, triplets, etc.)
4. Winners will be announced immediately following the judging of that age category.
5. Every tiny tot will receive a participation ribbon. Trophies will be awarded to the 1st place winner, ribbons to the 2<sup>nd</sup> and 3<sup>rd</sup> place winners.
6. All judges will be from outside Nelson County. Judges decision is final.
7. Summer play clothing only—no suits, no tux, or pageant type dresses.
8. All score sheets are the property of the Nelson County Fair Board Pageant Committee and these will not be distributed to any contestant, parent, or pageant coaches, etc.
