5. Judges are from out of town and their decisions are FINAL.
6. Winners WILL compete at the state pageant held the opening day of the State Fair in Louisville KY on August 17th 2017.

In the event the contest is cancelled due to weather, there will be no rain checks or refunds of entry fee or gate admissions.

Pageant will be moved to Samuels Hall or the Civic Center. If at the Civic center, there will be a \$5.00 charge per person to all who enter (this fee is not associated with fair admission/rides).
