## **Rules**

- 1) Contestant must have reached their 16<sup>th</sup> birthday and cannot have reached their 22<sup>nd</sup> birthday by October 31st of the current year. The winning contestant must show proof of age at the state Miss Kentucky County Fair Pageant in January.
- 2) Contestant must be single, never married and never have had children.
- 3) Contestant must be a permanent resident of state of Kentucky.
- 4) Contestant will be judged from the standpoint of personality, poise, and appearance.
- 5) Contestant will appear in swimsuit attire and evening gown.
- 6) Top contestants will answer an on-stage interview question.
- 7) Judges decisions are final.
- 8) Previous winners are not eligible to compete.
- 9) The winning contestant will be expected to retain her title until the following year. Marriage or motherhood constitutes loss of title.
- 10) Failure to comply with the fair board or pageant committee and their rules and regulations may result in dismissal from the pageant.
- 11) The winning contestant is expected to compete in the Miss Kentucky County Fair pageant to be held in January.
- 12) The winning contestant is expected to accompany the Little Miss & Mister at their pageant on the opening day of the State Fair in August.
- 13) Suitable prizes will be awarded to the winners.
- 14) All rules are in compliance with the Kentucky Association of Fairs and Horse Shows.
- 15) **No refunds/rain check given....this includes gate admission.** In case of rain this event will be moved to an alternative site.
- 16) **One female parent/chaperone allowed in dressing area. No cell phones allowed.**
- 17) Rules are subject to change without notice.
- 18) Contestant must not be affiliated with any other pageant system or organization.
