Entry Fee: \$20.00

1. Each contestant must be a resident of Nelson County.
2. Contestants must have reached their 8th birthday and cannot have reached their 11th birthday by July 1st of the current year.
3. Copy of Birth certificates provided with application.
4. Contestants will appear on stage in age-appropriate Sunday dress, sun dress or pantsuit. No "mini" skirts, bridal attire, or silk hose.
5. No one will be permitted backstage except appointed committee members.
6. Trophies will be awarded to the winner and runners-up.
7. Judges will be from outside Nelson County.
8. Previous winners of the Little Princess are ineligible.
9. Any contestant who has had professional training in pageantry or modeling, or has competed in pageantry or modeling professionally is ineligible.
10. In case of rain, pageant will be held at Bardstown Civic Center if needed
11. No refunds/no rain checks on gate admission if moved to alternate site.
12. Registration will be taken up till 5:30 p.m. day of contest.
13. Winners of this pageant do not advance to state competition.

All score sheets are the property of the Nelson County Fair Board Pageant committee and will not be distributed to any contestant, pageant coach, etc.
