## **Rules:**

- 1) Contestant must have reached their 8<sup>th</sup> birthday and cannot have reached their 13<sup>th</sup> birthday by October 31<sup>st</sup>. The winning contestant must show proof of age at the state Miss Pre-Teen Pageant.
- 2) Contestant must be single, never married and never have had children,
- 3) Contestants must be a permanent resident of state of Kentucky.
- 4) One *female* parent/chaperone allowed in dressing area. No cell phones allowed.
- 5) Contestants will be judged from the standpoint of personality, interview, poise, and appearance.
- 6) Contestants will appear in casual wear and **AGE APPROPRIATE** formal dress/evening gown.
- 7) Judges decisions are final.
- 8) Previous winners are not eligible to compete.
- 9) The winning contestant will be expected to retain her title until the following year. Marriage or motherhood constitutes loss of title.
- 10) Failure to comply with the fair board pageant committee and/or state rules and regulations may result in dismissal from the pageant and loss of title.
- 10) The winning contestant is expected to compete in the Miss Pre-Teen Kentucky County Fair pageant to be held in October.
- 12) Suitable prizes will be awarded to the winners.
- 13) All rules are in compliance with the Kentucky Association of Fairs and Horse Shows.
- 14) **No refunds/rain check given . . . this includes gate admission. In case of rain this event will be moved to an alternative site, either Samuels Hall or the Civic Center.**
- 15) Rules are subject to change without notice.
