REGISTRATION: Registration mail ins must be postmarked on or before July 6th with a cost of \$5.00 per entry/ per child; after this date---all late registrations will take place the night of the contest with a cost of \$10.00 per entry from 6:00-6:30pm---CASH ONLY. No refunds/no rain checks in case the event is cancelled.

RAIN SITE: will be announced through local media or Facebook (Nelson Fair); after 5pm or later. **NO PHONE CALLS** will be made that day.

RULES:

1. All those attending will pay gate admission.
2. All contestants must be a resident of Nelson County as of June 30, 2019. Proof of residency could be required if necessary.
3. Girls and boys will be judged separately in the following age groups as of June 30, 2019.
 - A. 25-36 months
 - B. 37-48 months
 - C. 49-59 months
 - D. Multiple births, 25-59 months (twins, triplets, etc.)
4. Winners will be announced immediately following the judging of that age category.
5. Every tiny tot will receive a participation ribbon. Trophies will be awarded to the 1st place winner, ribbons to the 2nd and 3rd place winners.
6. All judges will be from outside Nelson County. *Judges decision is final.*
7. Summer play clothing only-no suits, no tux, or pageant type dresses-points will be deducted.
8. All score sheets are the property of the Nelson County Fair Board Pageant Committee and these will not be distributed to any contestant, parent, or pageant coaches, etc.
