INFORMATION & RULES**

Date of Contest: Tuesday, July 16th @ 6:00 pm (Fairgrounds Grandstand)
Entry Fee: \$30.00 until July 1st; **\$35.00 thereafter**

Cash or money order only. No checks or debit/credit cards accepted.

1. Each contestant must be a resident of Nelson County.
2. Contestants must have reached their 8th birthday and cannot have reached their 11th birthday by July 1st of the current year.
3. Please provide a copy of birth certificate with application.
4. Contestants will appear on stage in age-appropriate **Sunday dress, sun dress or pantsuit**. No “mini” skirts, bridal attire, silk hose or pageantry dresses.
5. No one will be permitted backstage except appointed committee members.
6. Trophies will be awarded to the winner and runners-up.
7. Judges will be from outside Nelson County.
8. Previous winners of the Little Princess pageant are ineligible.
9. Any contestant who has had professional training in pageantry or modeling, or has competed in pageantry or modeling professionally is ineligible.
10. In case of rain, pageant will be held at an alternative site, to be announced through social media.
11. No refunds/no rain checks on gate admission if moved to alternate site.
12. Mail-in registration needs to be postmarked by July 1st of current year
13. Will take registrations up till 5:30 p.m. day of contest.
14. Winners of this pageant *do not advance* to state competition.

All score sheets are the property of the Nelson County Fair Board Pageant committee and will not be distributed to any contestant, pageant coach, etc.
