**RULES**

1. Contestant must have reached their 13TH Birthday and cannot have reached their 16th birthday by October 31st of the current year. The winning contestant must show proof of age at the state Miss Teen Kentucky County Fair Pageant in October.
2. Contestant must be single, never married, and never have had children.
3. Contestant must be a permanent resident of the state of Kentucky.
4. Contestant must be born a natural female.
5. Contestants will be judged from the standpoint of personality, poise, and appearance.
6. Judges decision are final.
7. Previous winners are not eligible to compete.
8. The winning contestant will be expected to retain her title until the following year, marriage or motherhood constitutes loss of title.
9. Failure to comply with the fairboard or pageant committee and their rules and regulations may result in dismissal from the pageant.
10. The winning contestant must compete in the Miss Teen Kentucky County Fair Pageant held in October. Suitable prizes will be awarded to winners.
11. Contestants may not compete in any pageant system that would profit the fulfillment of responsibilities through the state during her reign as a pageant title holder.
12. All rules are in compliance with the Kentucky Association of Fairs and Horseshows.
13. **No males allowed in dressing area.**
14. The winning contestant if able come to the fairgrounds/and or another location In Bardstown and do a practice mock interview before the state pageant in October of this year.
