## Rules:

- Contestant must have reached their 8th birthday and cannot have reached their 13th birthday by October 31st. The winning contestant must show proof of age at the state Miss Pre-Teen Pageant.
- 2. Contestant must be single, never married, and never have had children.
- 3. Contestants must be a permanent resident of the state of Kentucky.
- 4. One female parent/chaperone allowed in dressing room; no cell phones allowed.
- 5. Contestants will be judged from the standpoint of personality, interview, poise, and appearance.
- 6. Contestants will appear in casual wear and Age-Appropriate formal dress/evening gown.
- 7. Judges' decisions are final.
- 8. Previous winners are not eligible to compete.
- 9. The winning contestant will be expected to retain her title until the following year. Marriage or motherhood constitutes loss of title.
- 10. Failure to comply with fair board pageant committee and/or state rules and regulations may result in dismissal from the pageant and loss of title.
- 11. The winning contestant is expected to compete in the Miss Pre-Teen Kentucky County Fair pageant to be held in October.
- 12. Suitable prizes will be awarded to the winners.
- 13. All rules are in compliance with the Kentucky Association of Fairs and Horse Shows.
- 14. No refunds/rain check given this includes gate admission. In case of rain this event will be moved to an alternate site, to be announced on social media.
- 15. The winning contestant must come to the fairgrounds or via zoom to do a practice mock interview before the state pageant in October.
- 16. If mailing in your form it must be postmarked by July 1st of the current year, otherwise you may pay at the door. If paying day of event, entry fee will be \$75.00 cash only.
