

## Rules for the Nelson County Fair Baby and Tiny Tot Contest

Rain site: will be announced through local media or on Facebook (Nelson County Fair Pageants); and could be at 5pm or later. **NO phone calls will be made or taken on the day of the contest.**

**\*\*\*The Fair Board is not responsible for any traffic delays or if you are on a ride---which may cause you to miss your event—no refunds will be given.**

### RULES:

1. All those attending the fair must pay gate admission-----no refunds or rainchecks.
2. **All contestants must be residents of Nelson County as of June 30<sup>th</sup> of the current year—proof of residence must accompany the form.**
3. All contestants must be in one of the following age categories by **June 30<sup>th</sup> of the current year.**
  - Babies: 12-17 months 18-24 months Multiple Births  
\*\*\*If 2 years and a month –child must enter Tiny Tot Contest
  - Tiny Tots: 25-36 months 37-48 months 49-59 months Multiple Births  
\*\*\*if child is 5 years old (60 months) must enter the Little Miss & Mr. Contest
4. **All contestants must be in summer play clothing only. No tuxes, no suits, no pageant dresses, or anything that looks like formal wear (points will be deducted).**
5. Winners will be announced immediately following the judging of that age category. Pictures of the winners will also take place right after the winners are named
6. Every participant will receive a participation ribbon. Trophies will be awarded to the 1<sup>st</sup> place Winners. Ribbons will be given to the 2<sup>nd</sup> and 3<sup>rd</sup> place winners.
7. All judges will be from outside of Nelson County. **The judge's decision is final.**
8. All score sheets are the property of the Nelson County Fair Board Pageant Committee and these will not be distributed to any contestant, parent, grandparent, etc.
